

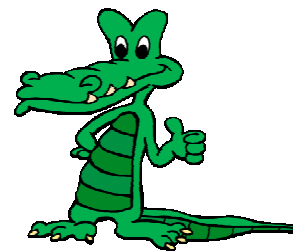

Lee County Tax Collector

A great pair of boots and a smile will take you places, just ask Larry D. Hart, Tax Collector. Introducing himself as "Your Friendly Tax Collector," it is clear that public service has been the driving force in Larry's life. As a graduate from local Riverdale High School, Edison Community College and Barry University, he has been a fixture in Lee County. Larry was elected Lee County Tax Collector in 2012 after being appointed to the position by Governor Rick Scott. Prior to being appointed Tax Collector, Larry served as Lee County's Assistant Tax Collector for 11 years. His focus has remained steadfast since joining the Lee County Tax Collector's office: treat everyone who walks through the door with kindness and respect.

Currently, Larry is Vice Chairman of the Board of Directors for SalusCare; Board Trustee for the Quality Life Center; and serves on the Board of Directors for the United Way, Hope Hospice, Florida Gulf Coast University Advocacy Program, and The Children's Advocacy Center of Southwest Florida. Always encouraging public service for our youth and excellence in law enforcement, Larry sits on the Congressional Nominating Committee that recommends students to attend our Military Academies, the FBI National Academy Association, and the International Police Chiefs Association.

As Tax Collector, Larry is responsible for the oversight of daily operations in all six Lee County Tax Collector locations and organizational strategic development. Larry's collaborative team approach develops and implements program goals for innovative and quality service.

2016-2017, Larry served as the President of the Florida Tax Collector's Association. He now currently sits on several Florida Tax Collector's Association committees and continues to develop strong working relationships with various state agencies and our local delegation. Larry takes pride in the Lee County Tax Collector Office's dedication to customer focused service.
