

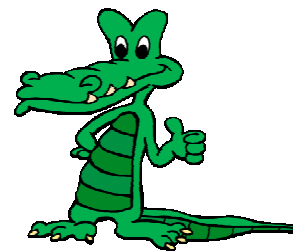

Nancy was widowed when her children were 11, 8 and 5, and she joined Northwestern Mutual as a Financial Advisor in 1984 as a means to help families plan and build financial security. She moved from Chicago to SW Florida in 1996 and has enjoyed her roles in Business, Rotary and the Community.
