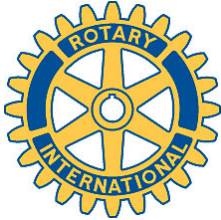

Release Agreement

In consideration of the sum set forth above, and the mutual obligations of the above parties involved in the Southwest Florida Nautical Market and Outdoor Expo (herein after called the "Event"), I the undersigned, on behalf of myself and any of my personnel participating in the Event and any corporate entity which I represent in the Event, if any, and on behalf of all of their personnel participating in the Event, hereby release, discharge, indemnify, defend, save and hold harmless the Rotary Club of North Fort Myers, Florida, the City of Cape Coral, Florida, all other Event Vendors, and all other Event Sponsors, their agents, respective officers, directors and employees (hereinafter collectively referred to as "Sponsors"), from any liability, claims, losses, demands, actions, fines, expenses, costs, judgments, all foreseeable and unforeseeable damages whatsoever, whether for personal injury, bodily injury (including death) or property damage arising during the Event or as a result of or due to participation in the Event. The undersigned, being fully aware of the risks and hazards inherent in participating in the Event, hereby voluntarily elects to engage in such activity and assumes all risk of loss, damage, or injury to person or damage to property, while engaged in such activity. This release shall be binding on the distributees, next of kin, heirs, personal representatives, executors, and the administrators of the undersigned or those of any individual who the undersigned is signing on behalf.

This release agreement shall extend to all claims, demands and causes of all action whatsoever arising wholly or in part from any act or omission of the Rotary Club of North Fort Myers, Florida, their officers, directors, and agents.

The undersigned further agrees not to vacate their assigned space prior to the end of the Event, 4 pm, EST, January 18, 2009. Upon the undersigned vacating the assigned space, the undersigned agrees to leave said space in the same state of cleanliness as when the undersigned initially occupied the space. Failure to comply with either of these stipulations will result in the undersigned, or the undersigned's corporate entity, becoming ineligible for any future Rotary Club of North Fort Myers, Florida sponsored events.

The undersigned irrevocably grants to the Sponsors the right to use his/her likeness in photographs, film or video for promotional use in any and all Media.

The undersigned further agrees that no refunds will be made due to cancellation by a Vendor. No refunds shall be made for inclement weather or other acts of God over which the Sponsors have no control and the risk and/or loss from such an event shall be borne by the Vendor.
