

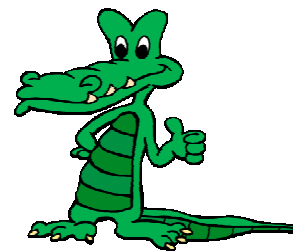

Allan was born in Boston, Massachusetts. Allan came from a family of doctors, his father being the rare breed of doctor who made house calls. His father's deep caring for his patients instilled a compassion for his fellow man in Allan. While Allan started college in pre-med, he was more interested in logic and philosophy. He graduated with a degree in philosophy from Jacksonville University in Jacksonville, Florida. Allan then went to the Cumberland School of Law at Stamford University in Birmingham, Alabama where he received his JD Degree in 1972.

Allan came to Ft. Myers and was an Assistant State Attorney under Joe D'Alessandro for two years and handled 34 felony cases from drug possession to murder. He then left to go into private practice and specialize in personal injury cases.

Allan is a member of the Academy of Florida Trial Lawyers, American Trial Lawyers of America, American Board of Trial Advocates, and the Lee County and Florida Bar Association. He has been a member of our Rotary Club since 2004, was our Rotarian of the Year in 2010, is a Major Donor to the Rotary Foundation (Paul Harris), and has annually conducted a pajama drive for homeless children during the Holidays. Allan truly exemplifies Rotary's Motto of Service Above Self.

Allan had the opportunity to make two trips to Israel last year and this year, and visit with his daughter and her husband and their four children. He will share his experiences of living in Israel and the things they cope with on a daily basis in their own country along with all the history he was able to see in his travels.
