

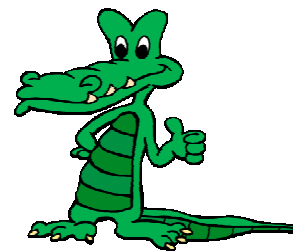

Lindsey Leman - NFM High Business Department

Lindsey is a CTE teacher at N Ft Myers High School. A graduate of Marshall University and the University of Charleston, both in West Virginia, she earned her Master's in Business Administration with a concentration in Economics and Accounting. Lindsey spent the first 7 years of her career in the accounting field. She then switched careers into the teaching field where she started at Clewiston High School. Lindsey has spent the last 3 years teaching AICE Business and Digital Information Technology at North.

Lindsey also is the advisor of the NFMHS Future Business Leaders of America Club. Future Business Leaders of America is the largest career student business organization in the world. Each year, FBLA-PBL helps over 230,000 members prepare for careers in business. Lindsey started the NFMHS chapter last year with 10 students and has almost tripled the growth this year, to 28 students. Last year every student from NFMHS placed at the FBLA District Competition and advanced to the Florida FBLA State Competition.

In addition to serving as the FBLA Advisor, Lindsey also serves as the STEM at Work Advisor. The STEM at Work program helps students learn about science, technology, engineering, and mathematic career fields. Each year this club offers students the opportunity to participate in field trips and internships, as well as experience hands-on activities through partnerships with businesses in the Southwest Florida community.
