Michelle Sargis is the Crime Prevention Specialist for North District. This includes, North Ft. Myers, Northern Cape Coral, Pine Island, Bokeelia, Alva and Boca Grande.

Michelle has been with the Lee County Sheriff's Office for 20 years and began her career as a certified law enforcement officer on road patrol in West District. After completing her Master's Degree in Human Resources, she couldn't resist her love for the classroom and became a certified D.A.R.E. instructor with the Youth Services Division. She taught the D.A.R.E. program (Drug Abuse Resistance Education) to 5th graders in 7 different Lee County Schools.

Michelle joined the Crime Prevention unit in January of 2007, and soon after, received state certification in both Crime Prevention and CPTED planning (Crime Prevention Through Environmental Design). Her primary responsibility as a Crime Prevention Specialist is educating citizens on how to help keep them from being victims of crimes; such as burglaries, frauds, scams, and identity theft. She also conducts many neighborhood watch and residential security programs throughout the community. Michelle is an instructor of our S.A.F.E. women's self-defense program and serves on the board of directors as Vice President for Southwest Florida Crime Stoppers. In her "spare" time, Michelle enjoys family activities with her husband and two children.
