

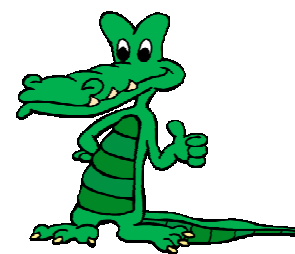

### Jill Palmer - Executive Director, American Red Cross

Jill is the Executive Director of the American Red Cross Florida's Southern Gulf Chapter serving Collier, Lee, Hendry & Glades counties. The American Red Cross shelters, feeds and provides emotional support to victims of disasters; supplies about 40 percent of the nation's blood; teaches skills that save lives; provides international humanitarian aid; and supports military members and their families. The Red Cross is a not-for-profit organization that depends on volunteers and the generosity of the American public to perform its mission. Jill is responsible for the recruitment and development of local volunteer leaders, serves as an ambassador in the community, and collaborates with community partners to bring awareness related to the mission.

Jill received a Master of Science in Health Science (MSHS), Health Services Administration and a Bachelor of Science in Health Services Administration with a minor in Legal Studies from the University of Central Florida. She has worked in volunteer and community service for more than 15 years. Jill was employed as the Director of Volunteer Services, Auxiliary Development and Arts in Healthcare at Lee Health (formerly Lee Memorial Health System).

Prior to joining the Red Cross executive leadership team as the Executive Director in 2017, Jill was a volunteer for over two years, serving as a member of the Board of Directors. In this capacity, she served as chair of the Volunteer Engagement & Mission Capacity Committee.

Jill received a Master of Science in Health Science (MSHS), Health Services Administration and a Bachelor of Science in Health Services Administration with a minor in Legal Studies from the University of Central Florida. In November 2010, Jill and her family experienced the loss of their home to a fire. Immediately following the fire among the first responders were volunteers from the Red Cross; Jill is intimately familiar with the Red Cross and its good work.
