

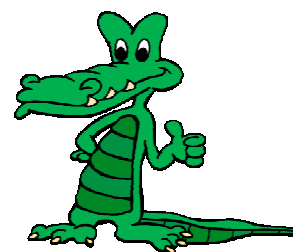

She currently serves on the Board of Directors for Good Wheels and remains active in her outreach and advocacy efforts by continuing to promote the importance of rehabilitation services for the blind throughout Lee, Hendry and Glades Counties.
