Most of you have heard of the “Honor Flights” that take Veterans to the War Memorials in Washington, D.C. Today, David will relate his experience as a Guardian during the recent Collier/Lee Honor Flight on May 4, 2019. The goal of the Collier/Lee Honor Flight is to transport local Veterans to Washington, D.C. to visit the various war memorials to honor their service and sacrifices to our country. Top priority is given to our most senior heroes – survivors of WWII, the Korean War, the Vietnam War, and any veteran with a terminal illness who wishes to visit their memorial.

Collier/Lee Honor Flight is a 501 (c) 3 charitable organization comprised of an all-volunteer group of hardworking individuals. Not a single person receives a paycheck, reimbursement for any lunches, or any mileage expense. Every donated dime goes directly to transporting Veterans to D.C. Each individual flight (mission) has a price tag of \$100,000.00. It is totally funded locally by businesses, individuals, and clubs like Rotary; the organization receives no government funding at all. They are currently preparing Mission 20 and trips are simply not possible without public awareness, support, and relentless fundraising efforts of the all-volunteer team.
