John Gardner - Your Home Owners Insurance And New Provisions You Need To Be Aware Of !!!

John has been a member of our club for nine years and has served on our board, is a Past-President (2015-16), is a multiple Paul Harris Fellow, and our Rotarian of the Year in 2018.

John owns Lee County Insurance and will present some important information we all need to know about our home owners insurance.

There are big changes that people need to be aware of regarding insurance claims processes and replacement cost coverage for their homeowners insurance. With a 13 year gap between hurricanes in Florida and then 3 active years of storms, policy holders really need to review their homeowners insurance policies and take note of a few provisions.

Labor & Material costs have skyrocketed especially for roofing and aluminum pool cages. The insured value of most homes needs to be adjusted to accommodate these increases in order to avoid a co-insurance penalty that is contained in many policies. In addition to these factors, you also need to determine if your Law & Ordinance coverage is adequate and if you have a guaranteed replacement cost endorsement (but its not 100% guaranteed).

Now is the time to check on your personal homeowners insurance policy and make sure you are properly covered.
