

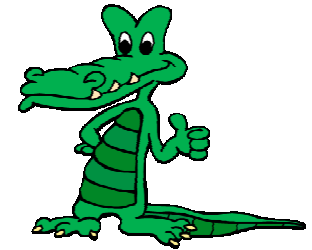

Carol Weidlich - Genealogy

Carol was born and raised in Rochester, New York. She lived there until 1970 when she relocated to Connecticut for school. While in Connecticut, Carol worked in the travel area for a large defense contractor and for a major insurance company; she coordinated conference appearances and later managed major accounts. Carol and her husband Jim of 35 years enjoyed sailing in the waters around Long Island Sound. They retired to Southwest Florida in July of 2000 where they live in North Fort Myers.

Carol's interest in family research didn't seriously begin until 1998. Since then she has researched her father's line back to 1790 (documented) in the U.S., Canada and England and to 1890 (documented) in Germany. Researching her mother's line has gone back to the very area she lived in when in Connecticut. Research brought her back to the 1600's, Founders of Hartford, Connecticut, and Revolutionary War patriots.

Carol has been a member of the Lee County Genealogical Society since 2000, and is currently the immediate Past President, Membership Chair, Webmaster, and facilitator of the RootsMagic (genealogy software) Special Interest Group. Carol also holds membership in the New York Genealogical and Biographical Society, the Jefferson County (NY) Genealogy Society, and the Estero Island Chapter of NSDAR.
